- 5.) The bidder shall deposit the EMD as required in the tender document, electronically through their respective internet banking enabled account or NEFT/RTGS, to the payment gateway of the 'e' tender portal
- 6.) Tenders must be submitted through online up to 10:00 AM (As per Server Clock) on the last date mentioned in column 8. Tenders received through online shall be opened at 11:00AM (As per server clock) on the opening date as per column 6 in the office of the Estate Office, Tamil Nadu Veterinary and Animal Sciences University, Madhavaram Milk Colony, Chennai-51. If the date of opening happens to be a holiday, the tenders will be opened on the next working day at the same time and venue.
- 7.) The tenders received will be opened through online by the Estate Officer, TANUVAS, Chennai, on the dates indicated in column No.6 on the tender date as noted in as per server time in the presence of the bidders or their authorized representatives who choose to be present. After the evaluation to the cover I (PQ) the successful bidder will be intimated the date of Cover II (BOQ) opening through online.
- 8.) The EMD amount should be the exact amount and no excess or less amount should be transferred through online payment gateway. If excess or short, the tender status will be shown as invalid. And the Unsuccessful tenderers EMD will be refundable to the tenderers within 90 days from date of receipt of tender or after the final process of the tender whichever is earlier.
- 9.) The tender notice is posted on TANUVAS's Website viz., [www.tanuv.ac.in](http://www.tanuv.ac.in) & <http://tntenders.gov.in> to ensure speedy and wide coverage.
- 10.) Tenders which are not digitally signed will not be accepted.
- 11.) Each bidder shall submit only one Bid, either individually, or as a partner in a partnership firm or a partner in a Joint Venture or a public limited firm. A Bidder who submits or participants in more than one Bid (other than as a sub-contractor or in cases of alternatives that have been permitted or requested) will cause all the proposals with the Bidder's participation to be disqualified.

**CONDITIONS FOR TENDER DOCUMENTS:**

1. Tenders which are not digitally signed will not be accepted.
2. Subsequent corrigendum/addendum if any shall only be available in website indicated above.
3. The Estate officer has the right to reject any or all tenders without assigning any reasons.
4. Other details can be seen in the tender documents. The Tender Inviting Authority shall not be held liable for any delays due to system failure which is beyond its control. Even though the system will attempt to notify the bidders of any tender update, the Tender Inviting Authority shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to the tenders.
5. The contractors those who have registered their names in TANUVAS (or) PWD or any other State/Central Government departments in the appropriate class and monetary limit, are only eligible to participate in the tender and they are requested to upload the up to date renewal registration (scanned) copy

issued by the department concerned. The contractors those who have carried out such type of similar works are the most preferable.

6. No bidder is permitted to withdraw his/their tender at any stage. If any bidder withdraws his/their offer within the tender validity period his/their EMD/SD shall be forfeited and his/their name(s) will be recommended for black listing.

7. The performance, quality of work. Character and integrity of the aspiring bidders should be satisfactory. Also the contractor should have executed building/related works within the agreement period of extension of time granted.

8. The Bidder should upload only the necessary documents required in the tender documents.

9. The bidders have to accept the on-line user portal agreement which contains the acceptance of the all the Terms and Conditions of NIC and tender document, undertaking and the e-Procurement system through <https://ntenders.gov.in> in order to become an eligible bidder. This will be a part of the agreement.

10. Price adjustment clause is not operable for this contract and this is fixed rate contract and the quoted amount should remain 'FIRM' during the entire period of completion of work. No cost escalation clause is applicable to this tender.

11. Further particulars may be obtained at the office of the Estate Officer, TANUVAS, Chennai-51 on any working day during office hours.

**NOTE:**

1. The tenderer should be registered with GST.
2. The tenderers shall furnish the performance certificate of works should contain the details such as Agreement value, period fixed for completion, actual Date of completion, extension of time granted if any along with fine imposed if any, value of work completed, performance of the contractor.
3. The total value of a contract which exceeds Rs.2.50 Lakhs I.T @ 2.2% TDS Source will be deducted.
4. The tenderer shall quote the rates and prices (both in figures and words) for all the items of the works described in the Bill of Quantities including GST.
5. Government of India has notified vide Notification No.20/ 2017 - Central Tax (Rate), dated 22nd August, 2017 and Notification No. 24 / 2017 - Central Tax (Rate) dated 21st September, 2017, the concessional rate of the Goods and Services Tax (GST) at 12% [ CGST at 6% + SGST at 6%] is leviable for any Government Contract, whether Civil or Electrical, irrespective of the Goods and Services Tax (GST) rate applicable on purchase of goods used in the execution of Government Contract. And the GST amount will be calculated at 12% from the sum of total tendered value quoted by the tenderer for construction cost (excluding GST) specified in the BOQ, subject to GST rate applicable from time to time as recommended by the GST Council.
6. All duties, taxes, and other levies except GST, payable by the contractor under the contract, or for any other cause shall be included in the rates, prices and total Bid Price submitted by the Bidder.

7. The Contractor should be required to indicate their GST registration number under the Goods and Service Tax (GST) Act 2017 in the tender form. The Central Goods and Service (CGST) Act 2017, the Integrated Goods and Services (IGST) Act 2017 and the Tamil Nadu Goods and Services (TNGST) Act 2017 have been enacted and enforced from 01.07.2017. Under the new tax regime, GST (comprising CGST, SGST and IGST) on works contracts for Government work was finally notified at 12 percent, as per the Tamil Nadu Goods and Services (TNGST) Act 2017, with effect from 01.07.2017.
