Having Digital Signature certificate (DSC) issued from any agency which is available in the portal and authorized by Controller of Certifying Authority (CCA), Government of India.

- 2.) Tender opening date & time: INDICATED in COLUMN (6) at 12.09.2023, 11:00 AM.
- 3.) The Tender notice is also available in www.tanuvas.ac.in and http://tntenders.gov.in

- 4.) The bidder shall deposit the EMD as required in the tender document, electronically through their respective internet banking enabled account or NEFT/RTGS, to the payment gateway of the'e' tender portal.
- 5.) Tenders must be submitted through online up to 10:00 AM (As per Server Clock) on the last date mentioned in column 8. Tenders received through online shall be opened at 11:00 AM (As per server clock) on the opening date as per column 6 in the office of the Estate Office, Tamil Nadu Veterinary and Animal Sciences University, Madhavaram Milk Colony, Chennai-51. If the date of tender opening happens to be a government holiday, then the tenders will be opened on the next working day at the same time and venue.
- 6.) The tenders received will be opened through online by the Estate Officer, TANUVAS, Chennai, on the dates indicated in column No.6 on the tender date as noted in as per server time in the presence of the bidders or their authorized representatives who choose to be present.
- 7.) The EMD amount should be the exact amount and no excess or less amount should be transferred through online payment gateway. If excess or short, the tender status will be shown as invalid. Unsuccessful tenderers EMD will be refundable to the tenderers within 120 days from date of receipt of tender or after the final process of the tender whichever is earlier.
- 8.) The tender notice is posted on TANUVAS's Website viz., www.tanuvas.ac.in & http://tntenders.gov.in to ensure speedy and wide coverage.
- 9.) Tenders which are not digitally signed will not be accepted.
- 10.) Each bidder shall submit only one Bid, either individually, or as a partner in a partnership firm or a partner in a Joint Venture or a public limited firm. A Bidder who submits or participates in more than one Bid (other than as a subcontractor or in cases of alternatives that have been permitted or requested) will cause all the proposals with the Bidder's participation to be disqualified.

CONDITIONS FOR TENDER DOCUMENTS:

- 1. Tenders which are not digitally signed will not be accepted.
- 2. Subsequent corrigendum/addendum if any shall only be available in website indicated above.
- 3. The Estate officer has the right to reject any or all tenders without assigning any reasons.
- 4. Other details can be seen in the tender documents. The Tender Inviting Authority shall not be held liable for any delays due to system failure which is beyond its control. Even though the system will attempt to notify the bidders of any tender update, the Tender Inviting Authority shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to the tenders.
 - 5. The contractors those who have registered their names in TANUVAS / PWD or CPWD or any other Tamilnadu government department under the appropriate class with experience in similar type of work and monetary limit, are only eligible to participate in the tender and the registered contractors are requested to upload the renewal registration (scanned) copy issued by the department concerned for the year of 2022-2023 received from the competent authority.
 - 6. The bidder should produce proof of Experience certificate from appropriate authorities of having satisfactorily completed as mentioned in the tender document.

- 7. No bidder is permitted to withdraw his/their tender at any stage. If any bidder withdraws his/their offer within the tender validity period his/their EMD/SD shall be forfeited and his/their name(s) will be recommended for black listing.
- 8. The performance, quality of work. Character and integrity of the aspiring bidders should be satisfactory. Also the contractor should have executed building/related works within the agreement period without extension of time granted.
- 9. The Bidder should upload only the necessary documents required in the tender documents.
- 10. The bidders have to accept the on-line user portal agreement which contains the acceptance of the all the Terms and Conditions of NIC and tender document, undertaking and the e-Procurement system through https://tntenders.gov.in in order to become an eligible bidder. This will be a part of the agreement.
- 11. Price adjustment clause is not operable for this contract and this is fixed rate contract and the quoted amount should remain 'FIRM' during the entire period of completion of work. No cost escalation clause is applicable to this tender.
- 12. The tenderer should furnish a letter from the Notary Public that there is no Criminal case registered against the, contractor /agency either pending or disposed. Any history of indulging in criminal cases will be a bar for participating in the tender. Tenders without this certificate will be summarily rejected.
- 13. Further particulars may be obtained at the office of the Estate Officer, TANUVAS, Chennai-51 on any working day during office hours.

NOTE:

- 1. The tenderer should be registered with GST council.
- The tenderers shall furnish the performance certificate of works that contains the details such as Agreement value, period fixed for completion, actual Date of completion, extension of time granted if any along with fine imposed if any, value of work completed, performance of the contractor.
- 3. If the total value of a contract which exceeds Rs.2.50 Lakhs I.T @ 2% TDS Source will be deducted.
- The tenderer shall quote the rates and prices (both in figures and words) for all the items of the works described in the Bill of Quantities including GST.
- 5. Government of India has notified vide Notification No.20/ 2017 Central Tax (Rate), dated 22nd August, 2017 and Notification No. 24 / 2017 Central Tax (Rate) dated 21st September, 2017, the concessional rate of the Goods and Services Tax (GST) at 12% [CGST at 6% + SGST at 6%] is leviable for any Government Contract, whether Civil or Electrical, irrespective of the Goods and Services Tax (GST) rate applicable on purchase of goods used in the execution of Government Contract. And the GST amount will be calculated at 12% from the sum of total tendered value quoted by the tenderer for construction cost (excluding GST) specified in the BOQ, subject to GST rate applicable from time to time as recommended by the GST Council. Out of the 2% (1% for TNGST, 1% CGST) will be recovered at source and will be paid to the contractor's GST account.

- All duties, taxes, and other levies except GST, payable by the contractor under the contract, or for any other cause shall be included in the rates, prices and total Bid Price submitted by the Bidder.
- 7. The Contractor should be required to indicate their GST registration number under the Goods and Service Tax (GST) Act 2017 in the tender form. The Central Goods and Service (CGST) Act 2017, the Integrated Goods and Services (IGST) Act 2017 and the Tamil Nadu Goods and Services (TNGST) Act 2017 have been enacted and enforced from 01.07.2017. Under the new tax regime, GST (comprising CGST, SGST and IGST) on works contracts for Government work was finally notified at 12 percent, as per the Tamil Nadu Goods and Services (TNGST) Act 2017, with effect from 01.07.2017.
- 8. As per GOI Notification No.20/2017 dt 22.08.2017 and GOI Ministry of Finance press release made on 29.06.2022, Work contract supplied to Central or State Governments, Local authorities for historical monuments, Canals, Dams, Pipelines, Plants for water supply, Educational institutions hospitals etc., & Sub contract thereof, the rate of GST Revised from 12% to 18% with effect from 18.07.2022.
