Competitive rates may be quoted for the **Establishment of Feed Block Unit with all accessories including solar dryer – 01 number at Livestock Farm Complex, TANUVAS, Madhavaram, Chennai 600 051**. The offer should be kept **valid for six months** from the date of award of contract and the work is expected to begin immediately and installation of machineries should be completed within 42 days. The prices quoted shall include basic cost and other taxes (GST, Road permit, Octroi etc.), duties (Excise, Custom etc.), Insurance, freight, transportation (F.O.R basis) of Feed block Manufacturing equipments to the site, packaging, inspection charges, unloading the equipment at the site, including installation and commissioning charges, accommodation and food expenses for your staff working at the site during installation and commissioning of the Feed Block Manufacturing Units.

Manufacturers / Suppliers bidding for **Establishment of Feed Block Unit with all accessories including solar dryer – 01 number at Livestock Farm Complex, TANUVAS, Madhavaram, Chennai 600 051** should submit **Earnest Money Deposit of Rs. 30,000/- (Rupees Thirty thousand only) through online mode** as per the e-tendering protocol” failing which the e-tenderer will not be admitted for financial bid opening. **At any stage of tendering process, if it is found that EMD amount is lesser than Rs. 30,000/-, the tender will not be considered.** The Earnest money deposited will be refunded to the unsuccessful tenderers. In the case of successful tenderers, the amount will be adjusted towards Security Deposit.

The successful tenderer, shall also furnish a **Security Deposit not exceeding 5% of value of tender and should sign an agreement in bond paper within 15 days from the date of intimation of the acceptance of the tender.** The Security deposit will be inclusive of the EMD, already remitted.

Demand draft / Cheques will not be accepted. If for any reason the tenderer withdraws the tender before or after being selected or before being rejected by the competent authority, The Tamil Nadu Veterinary and Animal Sciences University reserves the right to forfeit the deposit in part or in full.

The tender evaluation committee reserves the full right to accept / reject / cancel the tender as whole or part. However, clarifications may be sought on the tender details by the tender evaluation committee from the tenderer / bidder in writing at the time of collecting original demand draft if required. Uploading of all attachments mentioned in the tender is mandatory. E-bidders omitting any one attachment, submitting attachments containing incomplete information, wrong information will be summarily rejected.

Note:

- The firm should have at least five years of experience.
- Material of Construction (MOC) should be mentioned for all materials.
- Horse power details for all motors should be mentioned correctly.
- Adequate spares required for one year should be mentioned.
- Spares offered freely along with the feed block feed unit with all accessories including solar dryer should be clearly mentioned.
- Basic rates and GST should be quoted separately for each item
- One year guarantee must be provided for the plant.
- Tender with incomplete information or wrong information will be summarily rejected.
- The decision of technical evaluation committee is final related to tender evaluation of Supply, installation, testing and commissioning of Feed block Unit including all accessories with solar dryer
- The decision of financial evaluation committee is final related to any discrepancies in GST rates for machineries and commissioning of Feed block Unit including all accessories with solar dryer.
- Any expenditure incurred during installation and commissioning of the plant should also be included in the rate quoted. Separate cost outside the scope of the tender will not be entertained.
